

<b>Responsiveness:</b>	<ol style="list-style-type: none"> <li>1) Duly Notarized Power of Attorney authorizing the signatory of the Service Provider to submit the bid,</li> <li>2) Submission of Bid on prescribed Bid's Submission Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder,</li> <li>3) Submission of Price Schedule on prescribed Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder,</li> <li>4) Conformation/Compliance with Delivery Period,</li> <li>5) Conformation/Compliance with Bid Validity Period,</li> <li>6) Conformation/Compliance with Payment Schedule specified in the Special Conditions of Contract,</li> <li>7) Registration with Income &amp; Sales Tax Departments and proof of an Active Taxpayer of both kind of taxes,</li> <li>8) Submission of required Bid Security as per ITSP Clauses 16 &amp; 17 and corresponding details in Bid Data Sheet,</li> <li>9) Valid registration with Pakistan Engineering Council in relevant PEC Codes i.e. EE03, EE04, EE05 &amp; ME03, and</li> <li>10) Affidavit on judicial paper of at least Pak. As a minimum, the Service Provider's net worth for the last year calculated as the difference between total assets and total liabilities should be positive,</li> <li>2) Successful completion of at-least three (03) contracts rendering similar satisfactory services during last five (05) years to Government Departments/ Public Sector Organizations/ Entities/ Banks or Multi-National Companies,</li> <li>3) Documentary evidence establishing that the Service Provider is having services of relevant experienced technical and support staff like Diesel Generator Technician and Diesel Generator Mechanics etc. A list of relevant technical and support staff must be submitted along-with the bid, and</li> <li>4) Documentary evidence establishing that the Service Provider is equipped with relevant</li> </ol>



	tools/ equipment like Clamp Meter, Gravity Meter, Tester, Digital Multimeter, Screwdriver Set, Plier Set and Blower etc., that are required for service & troubleshooting of Generators by the technical support staff.
