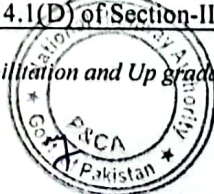

C. Financial Soundness

i) Average Annual Construction Turnover

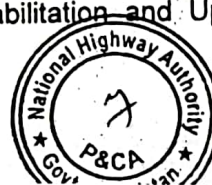
