- 12. The above recommendation of procurement committee was challenged by second lowest bidder i.e. M/s Rehman & Qureshi's Concern (Pvt) Limited, in response to which a **Grievances Redressal Committee (GRC)** was made comprising of the five members of this Ministry.
- 13. The GRC addressed the grievances of the Complainant. It thoroughly discussed the case and rejected the financial proposal of the lowest bidder M/s T.N & Company i.e. Rs.285,360/- (Inclusive Material cost and all applicable Taxes) against eleven (11) sanitary workers on the grounds of not following minimum wage policy of Federal Government that is Rs 25,000 per month and will be unable to execute the subject work within quoted financial bid keeping in view the material cost and other applicable taxes. Therefore, M/s T.N & Company does not meet the requirement/ terms and conditions of the tender as well as the government applicable rules/policies. Hence, the lowest bidder i.e. M/s T.N & Company has been disqualified by GRC while the second lowest bidder i.e. M/s Rehman & Qureshi's Concern (Pvt) limited meets the required criteria as per tender documents issued earlier by this Ministry and has been recommended for the award of this contract @ Rs.357,373/- (Inclusive Material & all Taxes) with ten sanitary workers.

GRC reviewed the whole case in the presence of the members of GRC and the representatives of the lowest and 2nd lowest bidders respectively i.e. M/s T.N & Company (Lowest) and M/s Rehman & Qureshi's Concern (Pvt) Limited (2nd Lowest). The relevant details of the case as per the minutes of the meeting of the Procurement/ Works Committee (Who opened & evaluated this whole tender/bids) is as under:-
- (i). Single Stage Two Envelope Procedure was adopted. Eight firms had submitted their technical bids out of which only six firm had qualified for the opening of their financial bids. The financial bids offered by these six firms are tabulated in detail as under:-

(ii). After comparing the above financial proposals, the Procuremen/Works Committee recommended M/s T.N & Company which quoted the lowest rates i.e. Rs.285,360/- per month (Inclusive all Taxes) as shown above.

- "Final Evaluation Report" as recommended by the Procurement/ Works Committee, was uploaded on the website of PPRA on 16.12.2022. Afterwards an objection was raised by the 2nd lowest bidder i.e. M/s Rehman & Qureshi's Concern (Pvt) Limited, that as per Government of Pakistan's policy, minimum wage of unskilled labour is Rs.25000/- per month and 16% GST is to be charged on Gross amount. M/S T.N & Company has quoted Rs.285,360/- per month for 11 janitorial workers (inclusive material cost and all government applicable taxes). As per government policy minimum wages of 11/workers will be 275,000/-GST will be Rs.44000/- and total amount will be 319,000/- without any material cost.
- The GRC thoroughly went through the case and observed after consultation with PPRA Director (Legal) that amount quoted by the lowest bidder, i.e., M/s T.N & Company does not follow the minimum wage policy and will also be unable to meet the material cost necessary for carrying out the subject work.
- The difference between the 1st and 2nd Lowest is that the 1st Lowest is not meeting the criteria of minimum wage which has been amended by the Federal Government whereas the 2nd Lowest is fulfilling all the criteria and has offered financial bid of Rs. 357,373/- Per Month (Inclusive Material cost & all applicable taxes) with total 10 Staff.
- Therefore, GRC unanimously proposed that the contract for the provision of Janitorial Services 6. for the MoST Building, may be awarded to M/s Rehman & Qureshi's Concern (Pvt) Limited (2nd Lowest Bidder), initially for a period of one year. The contract will be extendable for another one year on same terms & conditions subject to satisfactory performance of the Contractor. The firm should depute ten (10) sanitary workers as mentioned in their financial proposal at a total monthly cost of Rs.357,373/-(Inclusive all Taxes).


