M/S Al-Basit Enterprises Hyderabad	Qualified	It is to inform that M/S Al-Basit Enterprises participated in the said tender process by adopting both procedure <u>i.e manually and through online (E-Pads) systems</u> and after Technical Evaluation the said firm declared Technically qualified on grounds that the said firm submitted best quality sample of uniforms <u>i.e male/female including safari suits for PGs and Technical staff</u> according to the specifications and requirement of department as mentioned in the SBD of NHMP West Zone. Moreover, M/S Al-Basit Enterprises has fulfilled all the required codal formalities and documents. Furthermore, the Technical Committee checked online status of Income Tax / Sales Tax of said firm which <u>was found active</u> .
M/S R.CO Traders Lahore	Qualified	It is to inform that M/S R.CO Traders participated in the said tender process by adopting both procedure <u>i.e manually and through online (E-Pads) systems</u> and after Technical Evaluation the said firm declared Technically qualified on grounds that the said firm submitted best quality sample of uniforms <u>i.e male/female including safari suits for PGs and Technical staff</u> according to the specifications and requirement of department as mentioned in the SBD of NHMP West Zone. Moreover, M/S R.CO Traders has fulfilled all the required codal formalities and documents. Furthermore, the Technical Committee checked online status of Income Tax / Sales Tax of said firm which <u>was found active</u> .
M/S UK Tailors Haripur	Disqualified	It is to inform that M/S UK Tailors participated in the said tender process by adopting both procedure <u>i.e manually and through online (E-Pads) systems</u> and after Technical Evaluation the said firm declared Technically disqualified on grounds that M/S UK Tailors provided samples of uniform <u>i.e male and female only and failed to provide sample of Safari suit for PGs and Technical Staff</u> , however, provision of all sample is mandatory condition of said tender. <u>Moreover, the provided samples were not found according to specification of NHMP West Zone, because the said firm provided low stitched sample of uniform alongwith with low quality stitching material.</u> Furthermore, the said firm attached an unsigned affidavit of non-blacklisting with its technical proposal and without attestation from Notary Public. Furthermore, the Technical Committee checked online status of Income Tax / Sales Tax of said firm which <u>was found non-active</u> and <u>the firm is not financially sound and the capacity of the firm to carry out such huge work load is weak.</u>
