Moreover, Double Busbar Scheme is implemented instead of One and Half Breaker scheme.

- Bidder mentioned three 132 kV projects instead of required 220 kV AIS Grid Stations.
- For the other three claimed projects, the firm provided services only as "independent Engineer" for witnessing of testing/commissioning.

Therefore, similar experience could not be established as per clause 9 (b), Annex-2 of RFP which requires experience of consultancy services of substation consisting of similar scope.

Since M/s. EnMasse, Lahore – M/s OMS, Lahore (JV) has not provided consultancy services for construction supervision of 220kV AIS Substations in the last five years therefore it does not fulfill the requisite criteria of clause 9(b) of Annex-2 of the RFP document.

Hence the JV firm is declared as Non-responsive.
