

**Note:-** The designated Procurement Evaluation Committee during evaluation of the bids noticed that although the bid of M/s Stay Biz for Lot- 4 i.e. other Scanners and M/s Intime Associates for Lot 8 i.e. Air Conditioners were responsive yet the quoted prices by M/s Stay Biz and M/s Intime Associates for respective lots were on higher side as compared to the quoted prices of other bidders which were found non-responsive during evaluation process, whereas M/s Mega Plus was single responsive bidder for lot-10 i.e. VPN Connectivity Devices. Therefore an independent Price reasonability Committee was constituted with the approval of Competent Authority of BISP. **The Price Reasonability Committee after conducted market survey recommended re-tendering for lots 4, 8 &10** due to non-availability of quoted models of scanners and VPN Connectivity Device in the market, whereas the quoted price for Air Conditioners was found on higher side when it was compared with the market rates.
