

As shown in above comparative statement, the rates of officer chair mentioned at Sr#1 (Officer Chair), is unexpectedly on higher side, that's why due to less available budget said item needs to be dropped and quantity of item mentioned at Serial No.22 (Coat Hanger) needs to be curtailed from 10 to 4.
 - ii. It is also observed that two firms M/s SIM's Trading company and M/s Noor Enterprises has quoted same rates of item mentioned at S#22 (Coat Hanger) but committee decided to award the work order to M/s SIM's Trading company as the sample quoted by the firm is comparatively better than that of M/s Noor Enterprises.
