10.	Details of Bid Evaluation	<p>Sixteen Sealed tenders were received till the closing hour i.e. 11.00 am dated 30-11-2021 as mentioned in the tender documents. The Purchase Committee of the department, which is also assisting the purchases made under development projects. After the expiry of given time i.e. 12.00 a.m., the committee opened the sealed tenders/quotations on the same day i.e. 30-11-2021 in the presence of the bidders/representatives.</p> <ul style="list-style-type: none"> - Technical proposal of the eleven (11) firms were opened on 30-11-2021 for technical evaluation for category 1: Lab equipment. Financial evaluation of category 1 was done on 27-12-2021. - For items of category 2. Farm implements, two firms participated, the technical and financial evaluation of both the firms was carried out by the committee and where technically qualified, the lowest bidders' offer was recommended by the committee. - For category 3: office equipment, four firms participated in the bidding. Firms providing required specification and offering lowest rates were accepted. - For category 4: computer hardware and accessories, four (4) firms participated and firms with lowest bids were recommended. - For category 5 i.e. furniture and fixtures only two firms i.e. M/s Rozi Enterprises and M/s Insta Tech participated. Samples for furniture items were provided by two firms on 7-11-2021 and samples of M/s Rozi Enterprises were approved as they were as per specification. <p>The Purchase Committee as per detailed analysis of the specification and rates offered for items 1, 2, 3, 4, 6 and 7 of category 2 recommended to M/s Insta Tech and item 5 to M/s Margalla Enterprises. Under category 3, photostat machine was recommended to M/s Cosmotech Islamabad whereas water dispenser, LED Security Equipment were recommended for Margalla Enterprises while Backup supply generator was recommended for Insta Tech. Under Category 4: PCs, Laptop, printer and IT eqt was recommended for Insta Tech whereas UPS was recommended for SM Jaffar and Co being the lowest bidders. For category 5 i.e. furniture and fixture, all the samples of M/s Rozi Enterprises, Islamabad for officer/staff/computer tables, officer/staff/computer chairs, side racks, wall cabinets, steel almirah were as per specification and accepted. The Purchase Committee further recommended that vendor who has qualified the bid shall supply the items as per requirements, quality and in stipulated time. Delay in supply of item shall be reported in the PPRA and further necessary action as envisaged in the PPRA rules shall be exercised. Bidder was details is as follows;</p>
