

9. Criteria for Bid Evaluation:
 - a) The bidder must submit National Tax No., Sales Tax No. Certificates.
 - b) The supply should be in accordance with the approved specification/samples.
 - c) The vaccine meets the WHO requirements for biological substances.
 - d) Quality of the items should be maintained in good condition.
 - e) Supply of the above items is to be completed and supplied within one month
 - f) If job is not completed within the prescribed period according to approved specifications, the Ministry reserves the right to impose penalty by deducting payment from your bill.
 - g) The above items shall be delivered/handed over to representative of M/o RA&IH, Islamabad by the firm at their own expenses.
 - h) All payments to the firm shall be made after deduction of income tax under the rules.
 - i) No advance payment will be made by this Ministry. Earnest money (refundable) will be released on completion of job and submission of confirmation certificate from representative of M/o RA & IH, the payment shall be made to the firm.
 - j) The Procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submit a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds. **The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.**
 - k) A certificate mentioning name of countries where vaccine is supplied by the manufacturers would be provided by supplier.

The bid document of the firm revealed that the Flu Vaccine will be expiring on 30 th June, 2019, whereas Hujjaj's tentative departure is expected in first week of July, 2019. Ipso-facto, the vaccine will have expired by that time. In this regard Committee unanimously declared the bid non-responsive.
