5.0 CONCLUSION

Taking into consideration all the financial and technical proposals, all the environmental laboratories meet the criteria mentioned in RFP except those which have been highlighted in Table-2.

As per comparison, M/s Green Crescent Environmental Consultants (Pvt.) Limited is the lowest laboratory at their corrected bid price of Rs. 749,800/- (including 15% BRA Sales Tax).

M/s HSE Services is the second lowest laboratory at their corrected bid price of Rs. 778,090/- (including 15% BRA Sales Tax). Whereas, M/s SGS Pakistan (Pvt.) Limited is the highest laboratory at their corrected bid price of Rs. 1,729,600/- (including 15% BRA Sales Tax).

6.0 RECOMMENDATION

In the light of above conclusion, it is recommended that the works may be awarded to lowest evaluated laboratory M/s Green Crescent Environmental Consultants (Pvt.) Limited at their corrected bid price of Rs. 749,800/- (Rupees Seven Hundred Forty Nine Thousand Eight Hundred only) including 15% BRA Sales Tax.
