**LALAZAR, F.M KHAN AND KEAMARI KPT.**

**INTRODUCTION**

1. The Potable Water received from KW&SB is stored at TPX & then supplied to KPT Residential Area through bowsers and it is stored in the underground and overhead water storage tanks of different capacity at various locations of Residential Area of Lalazar, F.M Khan and Keamari KPT.

The routine cleaning of the underground & overhead tanks is mandatory as with a passage of time, a thick layer of mud, silt, garbage and other impurities gets accumulated in the tank and required to be taken out & removed to overcome and redress the complaints of contamination and dirty water, which may cause unhygienic conditions for the users.

Lastly some of the overhead & underground tanks were cleaned on 10-09-2020 and in line with the recurring nature of work, the AXEN (W/S) has prepared an Estimate amounting to Rs. 993,100.50 (based on current market rates including 13% SRB) to attend the work through outsource as the work is beyond the limits of In-house arrangements.

2. According the Rules 36 (a) of PPRA tenders for the work were invited through KPT / PPRA & MoMA Website 22-08-2023 and received on 11-09-2023.

**RECOMMENDATIONS**

The Lowest Evaluated Bid amounting to Rs. 919,537.50 (Rupees: Nine Hundred Nineteen Thousand Five Hundred Thirty Seven & Fifty Paise Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. SAK Contractors which is 7.40% Below the corresponding estimated cost of Rs. 993,100.50 based on current market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. SAK Contractors is considered capable for carrying out this work.

The Committee therefore, recommends the acceptance of the Lowest Evaluated Bid amounting to Rs. 919,537.50 (Rupees: Nine Hundred Nineteen Thousand Five Hundred Thirty Seven & Fifty Paise Only) received from M/s. SAK Contractors is considered reasonable for this work.
