INTRODUCTION:

1. The Karachi Port Trust Building also referred to as the KPT Building is a large colonial-era building in Karachi, Pakistan that serves as Head Quarters for the Karachi Port Trust which administers the Port of Karachi. It is also a land mark heritage building and the hub of port business. The building was constructed more than century ago and at present due to its regular maintenance and upkeep is one the maintained historical building with respect to its year of construction.
2. The main reception at other end from VIP reception from where all the officers / employees and visitors enters into this building was developed in the year 2005. During the period of last 18 years only minor repairs on as and when required basis were given. However, at present due to passage of time the reception requires some extensive repairs works to bring the same in shipshape condition to have a good impression for the visitors.
3. Photographs showing the Pathetic / faded floor tiles and walls placed at (F/A).
4. Accordingly, AXEN (MIY) has prepared an estimate amounting to Rs.3,126,131.44 (including all taxes) alongwith a plan placed at S. No. 2 (a) & 2 (b) respectively, to attend the work through outsources as the same is beyond the scope of In-house arrangements.
5. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through Press on 01-05-2024 & 02-05-2024 and KPT / MoMA & PPRA Website on 06-05-2024 and received on 23-05-2024.
