INTRODUCTION:

1. The subject bungalow has been designated as official accommodation for Chairman, KPT. Accordingly as per direction AXEN (QR) alongwith Sub Engineer visited the subject bungalow and found that, the security room of the Port House is in deteriorated condition & need to be repair & maintenance works. Accordingly, AXEN (QR) have prepared an Estimate amounting to Rs. 974,875.70 alongwith Plan (placed at F/B), to attend work through outsource as the same is beyond the scope of in-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 24-09-2024.

RECOMMENDATIONS



Keeping in view of their past performance as mentioned in Para-2 (m) M/s.SAK Contractors is considered capable for carrying out the work viz. **"MAINTENANCE / REPAIR TO SECURITY ROOM B-60 PORT HOUSE LALAZAR AREA"**.
