10.	Details of Bid Evaluation	<p>Ten (10) Sealed tenders were received till the closing hour i.e. 11.00 am dated 14-10-2024 as mentioned in the tender documents. The Purchase Committee of the department, is also assisting the purchases made under development projects. After the expiry of given time i.e. 11.00 a.m., the committee opened the sealed tenders/quotations on the same day i.e. 14-10-2024 at 12.00pm in the presence of the bidders/representatives. Online attendance of committee members and bidders were marked as well as uploaded on EPADs portal. Bidders technical proposals were checked and downloaded, bid securities were duly verified physically as well as on EPADs portal. Ten firms/bidders were provincially selected for technical evaluation. However, Three firm/bidder did not apply thorough EPADs, hence, not accepted for further process.</p> <p>Single Stage- two envelope bid evaluation method was followed;</p> <ul style="list-style-type: none"> - Technical proposal of the Ten (10) firms were opened on 14-10-2024 for technical evaluation and financial proposals were retained. - Technical evaluation of the proposal of all the Ten firms was done keeping in view the specification required. The firms which did not meet the technical specification, their proposals were rejected on technical grounds. - The Companies that qualified technically were communicated the technical evaluation outcome for financial evaluation of category 1-4 was done on 06-11-2024. • For category 01, Laboratory Equipment's, six (06) firms participated in the bidding. Firms providing required specification and offering lowest rates were accepted. • For category 02, Plant and Machinery, two (02) firms participated in the bidding. Firms providing required specification and offering lowest rates were accepted. • For category 03, Office Equipment's, three (03) firms participated in the bidding. Firms providing required specification and offering lowest rates were accepted. • For category 04, Computer Hardware & Accessories, three (03) firms participated in the bidding. Firms providing required specification and offering lowest rates were accepted. <p>2. The Purchase Committee as per detailed analysis of the specifications and rates offered for item 01 & 02 recommended to M/s Irfan Enterprises and for Item 03 recommended to M/s Rays Technologies of Category 01 (Laboratory Equipment's) and items 04, 05 of Category 02 (Plant and Machinery) recommended to M/s Pace Communication and System. Under Category 03 (Office Equipment's) items 07,</p>

08, 09, 10, 11 & 13 as well as item 18 of Categories 04 (Computer Hardware & Accessories) recommended to M/s Orion Enterprises. Items 17 of Categories 4 (Computer Hardware & Accessories) recommended to both M/s 3T Technologies SMC and M/s Avia Across, respectively, and for item 19 recommended to M/s Avia Across.

3. The purchase committee further recommended that vendor who has qualified the bid shall supply the items as per requirements, quality and in stipulated time. Delay in supply of item shall be reported in the PPRA and further necessary action as envisaged in the PPRA rules shall be exercised. Bidder details is as follows;

Ten firms/bidders were provincially selected for technical evaluation. However, Three firm/bidder did not apply thorough EPADs, hence, not accepted for further process.</p> <p>Single Stage- two envelope bid evaluation method was followed;</p> <ul style="list-style-type: none"> - Technical proposal of the Ten (10) firms were opened on 14-10-2024 for technical evaluation and financial proposals were retained. - Technical evaluation of the proposal of all the Ten firms was done keeping in view the specification required. The firms which did not meet the technical specification, their proposals were rejected on technical grounds. - The Companies that qualified technically were communicated the technical evaluation outcome for financial evaluation of category 1-4 to be done on 06-11-2024. Evaluation of technical proposals revealed following outcomes; <ul style="list-style-type: none"> • M/s Orion Enterprises applied for water dispenser, Air Conditioner, Refrigerated, LED TV, LED Conference room, and Laser Jet Printer for which it met the requisite technical criteria. • M/s The World-Wide Scientific applied for Centrifuges, Magnifying Lamps and Misc. Lab item (PCR) for which it met the requisite technical criteria. • M/s Meditron Trading Corporation submitted proposals for Centrifuges and Magnifying Lamps for which it met the requisite technical criteria. However, proposal for Misc. Lab item (PCR) did not meet the requisite specifications (No USB port and RS-232 port). Hence, rejected. • M/s Intermark Pvt Ltd submitted proposals for Centrifuges and Misc. Lab item (PCR) for which it met the technical criteria. • M/s Rays Technologies applied for Misc. Lab item (PCR) which was in compliance with requisite specification. Hence, accepted. • M/s 3T Technologies SMC Pvt Ltd submitted proposal for Water Dispenser, Air Conditioner, Refrigerated, LED TV, LED Conference room, Desktop Computer, Laser Jet Printer and Laptop for which it met the requisite technical criteria and were accepted for financial evaluation. • M/s Key Scientific Corporation applied for Centrifuges for which it met the requisite specification and accepted for financial evaluation.

- **M/s Irfan Enterprises** submitted proposal of Centrifuges and Magnifying lamp for which it met the requisite specification and were accepted for financial evaluation. However, bid for Misc. Lab item (PCR) were rejected on technical ground (No RS-232 port provision, neither password protected).
- **M/s Pace Communication & System** submitted proposal of High-resolution Camera, Tablet, Water Dispenser, Air Conditioner, LED TV, LED Conference Room, Desktop Computer, Laser Jet Printer and Laptop respectively for which it met requisite specification and were accepted for financial evaluation.
- **M/s Avia Across** applied for Centrifuges, Magnifying Lamp, Misc. Lab item (PCR), High Resolution Camera, Desktop Computer and Laptop respectively for which it met requisite specification and were accepted for financial evaluation.

The Purchase Committee further recommended that vendor who has qualified the bid shall supply the items as per requirements, quality and in stipulated time. Delay in supply of item shall be reported in the PPRA and further necessary action as envisaged in the PPRA rules shall be exercised. Bidder was details is as follows;

Single Stage-Two Envelope Bidding for Category 1-4, the technical bids were opened and the financial proposals were retained by the purchase committee. Upon evaluation, it was found out that all the ten companies qualified for a single or more category items and hence all the participating firms were eligible for participation in financial evaluation. However, for Category 5, 3 bidders participated physically but none of them uploaded their bids on EPADs portal, hence, their bids were not accepted.
