Dragon Security Services quoted rates which are in accordance with the labour laws maintaining minimum wage rate of Rs. 32000. Hence, the Committee unanimously recommended to issue work order to M/s. Dragon Security Services to provide security services to DG I&P Hqrs, Islamabad and 164 Regional Passport Offices throughout Pakistan on the quoted rates as per financial bids.
