### Pre-Qualification Process

Federal Board of Revenue (FBR) invited "Pre-Qualification Applications" to pre-qualify vendors for supply of Video Analytics Equipment & Services through publication of advertisement in the national dailies "Dunya" and "The News" dated, 07<sup>th</sup> October, 2020 as well as uploaded on PPRA and FBR websites.

2. Deadline for submission of Pre-Qualification Applications was 22<sup>nd</sup> October, 2020 at 1600 hours. To foster competition.

3. On pre-fixed due date and time, following seven (07) vendors submitted their Pre-Qualification Applications:-

## Recommendation

7. In view of the above, the Committee recommended the pre-qualification of following Vendors to supply Video Analytics Equipment & Services for next **three (03) years**:-

8. In addition, the Committee proposed following measures for fostering transparency and avoiding collusion between pre-qualified vendors firms while inviting Quotations by Manufacturers of Specified Goods:-

- (a) Specification of requirement would be clearly mentioned in the Request for Quotation (RFQ);
- (b) Only sealed quotations would be obtained/ accepted from the pre-qualified vendors;
- (c) Quotations would be opened in a meeting of the designated Procurement Committee of Manufacturer;
- (d) If a Vendor is not willing to respond to Manufacturer's RFQ, it would be prudent to obtain a regret letter from that vendor; and
- (e) Manufacturers shall be responsible to address and respond all grievances raised by any of the vendors during the bidding process.
- (f) Considering the confidentiality of the Data/information, a Non-Disclosure Agreement (NDA) shall be signed between FBR and Pre-qualified firms.
