- e) Operational Experience of Bidder/ Manufacturer's Same Brand Vehicles in Local Market. **(Marks Allocated 05)**
- f) Manufacturer's Production Experience of Similar Nature (Last 10 Years). **(Marks Allocated 15)**
- g) Chassis Origin (availability of spare parts and servicing.) **(Marks Allocated 05)**
- h) Superstructure (i.e. Crew-Cab, Equipment and Pump Compartment) in corrosion-resistant material. **(Marks Allocated 05)**




- i) Technical Matching of Product with Main Specifications as Annexed (EU/USA/Japan Origin only). **(Marks Allocated 10)**
- j) Water Tanker / Bowser (Monitor & Pump EU/USA/Japan origin only). **(Marks Allocated 10)**

The total sum of above categories / sub categories is 100 Marks. It is mandatory for bidders to obtain 80marks out of said total marks.


