Disqualified: - The Technical Committee has evaluated the proposal received against subject tender requirements and identified several mandatory documents (**Mandatory Clause of RFP**) being missing from hard & soft copies both inclusive. Details are provided as following:

(a) Annex "II" Form B, Page 47 clause 3(m) and Annex "XIV" (URD-01) Page 19 clause 4 (i) "**Training Plan and Training material documentation is missing**".

(b) Annex "II" Form B, Page 47 clause 3 (n) "**According to Annex "XIV" (URD-01) Para 2, bidder was bound to submit SLA for Cloud Hardware Solution, Cloud Orchestration Software and Data Centre Hosting for proposed Agriverse solution. However, only SLA for Data Centre Hosting was provided**".

(c) Annex "II" Form B, Page 47 clause 3 (f) "**Bidder was bound to provide experience of installation of 20 racks for data Centre. However, incomplete information related to 20 racks experience was submitted. Additionally, No reference was given in support of this requirement whereas 03 references are required**".

(d) Annex "XIV" (URD-01), Page 19 clause 4 (h) "**Support and maintenance plan**" for (a) Cloud Hardware Solution (b) Cloud Orchestration Software and (c) Data Centre Hosting was not provide however partial information has been provided by one vendor of consortium. Hence it does not qualify the requirement of RFP.

As per Section 31 of PPRA Rules 2004. No bidder shall be allowed to alter or modify his bid after the bids have been opened. However, the procuring agency may seek and accept clarifications to the bid that do not change the substance of the bid. M/s PMCL-Jazz didn't fulfill the mandatory requirements to clear the passing marks.
