## 11. Any other additional / supporting information (the procuring agency may like to share):

The Committee found various arithmetic errors while examining both original and supplementary financial proposals of the bidders. In order to ensure transparency, representatives of all three (3) bidders were simultaneously invited on October 29, 2020 to make such corrections in presence of all the bidders and committee members. It is pertinent to mention over here that M/s InfoTech did not add obvious cost components while calculating the total cost. In this regard, the concerned bidders i.e. M/s Abacus Consulting and M/s Infotech were required to make corrections to eliminate arithmetic errors found in their financial proposals. However, no bidder was allowed to alter, modify, add or remove any of the cost or omit any part of its bid.
