The technical proposal of the Bidders shall be evaluated for qualification of bidders for the subject Bid based on the criteria regarding Eligibility, Work Experience, Equipment Capabilities and Financial Soundness as follows;

The overall minimum qualifying score shall be 70% marks and fulfilling the basic / mandatory requirements to qualify. A detailed qualification criterion is given hereunder.

3. (i) Basic Eligibility (mandatory)

The firms fulfilling the following basic requirements shall only be considered for further evaluation (relevant documents to be attached).

- a) Proof / Documents of registration as supplier or Manufacturer / Sole proprietor / partnership deed / Memorandum of Association of Firm in case of Limited Company or Registration of FBR as supplier etc.
- b) The bidder must be registered with Sales Tax and Income Tax Departments and must be on FBR's Active Tax Payer's List **(documentary proof must be submitted along with bid)**.
- c) Litigation history / Affidavit on Legal Stamp paper in original to the fact that no litigation hinders the bidder to participate in this tender.
- d) Affidavit on legal stamp paper declaring that the firm has never been black listed.
- e) Affidavit on legal stamp paper declaring that the firm has supplied the material within due time for last two years in CSF/Directorate. If the firm is already working in CSF/Directorate.
- f) Bid Security as mentioned in tender documents from Scheduled Bank in Pakistan in favor of MD/CSF or FA&CAO/M&S, Pakistan Railways, Headquarters office Lahore as per BDS (Clause-18).




