



Responsiveness:	<ol style="list-style-type: none"> 1) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid, both electronically and hard copy to be furnished separately. 2) Submission of Bid on prescribed Bid's Submission Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder [Bids submitted otherwise, shall not be accepted]. 3) Submission of Price Schedule on prescribed Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder [Bids submitted otherwise, shall not be accepted]. 4) Submission of Bid Security with the Bid, as mentioned at ITB 16.1 to 18.3 hereunder and in the Invitation for Bids Notice, 5) All pages of Bid should be duly signed by the authorized representative and stamped, 6) Conformation/Compliance with Delivery Period, 7) Conformation/Compliance with Bid Validity Period, 8) Conformation/Compliance with Payment Schedule specified in the Special Conditions of Contract (deviations in payment schedule shall not be accepted), 9) Registration with Income & Sales Tax Departments and proof of an Active Taxpayer of both kind of taxes, and 10) Affidavit on judicial paper of at least Pak. 
