Dealers/resellers, registered with Income Tax and Sales Tax Department and who have provided Active Taxpayers list of FBR, were evaluation/comparison. , According for bid to Technical Comparison, bid of one firm "M/s PMCL (Jazz)" is rejected / declared Non-Responsive due to non-submission of bid on NHA prescribed form. Comparative statement duly signed by the Purchase Committee-III at (F/H).

Rejection

- 16. As per Instructions to Bidders, General-para (b), "Bid document should be signed and stamped on each page by the designated authorized representative of the bidder. Bids would be considered only in the prescribed form/ document. Bids not submitted on prescribed form will be summarily rejected."
 - a) M/s PMCL (Jazz) did not followed the "Instructions to Bidders" and submitted their bid without Bid Document. They have not accepted NHA's Terms and Conditions, removed all relevant bid clauses and amended the title of **Annex-A** for BOQ (F/I)..
 - b) As per Terms and Conditions, Qualification Criteria Clause (e) The CPE device (H685w WCDMA Cellular Router) proposed by M/s PMCL (Jazz) is not 4G supported. WCDMA stands for (Wideband Code Division Multiple Access), and is the 3G technology cellular with Wi-Fi wireless network and share a cellular broadband connection.
 - c) Moreover, the H685w quoted by M/s PMCL (Jazz) is a UMTS (Universal Mobile Telecommunication System) which is a 3G standard. Whereas it was clearly written under Terms and Condition Qualification Criteria Clause (e) "The CPE device should be 4G supported, able to fall back on 3G and 2G." Hence M/s PMCL (Jazz) are disqualified for the Bid No. 111 and their bid is summarily rejected.

Acceptance

M/s CMPak Limited has quoted B310s -927 which is LTE (Long Term Evolution) and is a **4G** standard. Bid of M/s CMPak Limited was found lowest evaluated and responsive.
