- Sample "1/2 & 2/2" (Atta) not evaluated quantity not sufficient provide atleast 5 Kg.
- Sample "1/2" (Cooking Salt) Rejected due to not iodized.
- Sample "1/2 & 2/2" (Sweet Corn) SMS brand rejected inconsistent quality.
- Sample "1/2 & 2/2" (Mushroom) SMS brand rejected inconsistent quality.
