INTRODUCTION

After rain alongwith Heavy / Gusty Winds on 18-05-2021, the concerned DTM (E) vide letter placed at S.No. 1 has informed about leakage alongwith missing / fallen down ACC sheets & rusted Valley gutter of Motor Shed at East Wharf. More over the leakage through damaged / missing / broken ACC Sheets also creates problems during the rain and requires replacement. The Traffic Department is also stressing very hard for the early repair and maintenance of the same in order to save the valuable vehicles Park in the Shed. The work as detailed is beyond the scope of Departmental labour & the Last work was executed in the year 2004.

Keeping in view the safety KPT AXEN (KW) carried out a survey of the site, the has an prepared an Estimate Plase at (S. No. 4A) amounting to Rs.996,660.00 as the Work is beyond the In-house arrangements of K.P.T, therefore, Tenders for the work were invited through KPT / PPRA Websites and were received on 08-09-2021, accordingly under the PPRA Rule 36(a).

RECOMMENDATIONS


