

M/s Mega Plus (Lot-1, 2 & 3) and M/s Office Automation Group (Lot-4) were found single responsive bidders for the respective Lots. In the light of PPRA guidelines, Price reasonability of the quoted prices by M/s Mega Plus (Lot-1, 2 & 3) and M/s Office Automation Group (Lot-4) will be determined before processing of contract award for Lots 1,2,3 & 4.

For Lot-5 (A3 Black and White Printer), none of the bidders was found responsive. For Lot-6 (USB-3.0 - 30 Nos., Portable Hard Drive-10 Nos.), although the bid of M/s Fast Tracks was declared responsive however, the quoted price of Rs. 2,650,100 was found on the much higher side as compared to cost estimates and the quoted prices of the other bidders who otherwise became non responsive due to non-compliance of Eligibility criteria, therefore, BISP has decided to re-invite the bids for Lot-5 and the Lot -6s.
