

Ltd is responsive and technically qualified, however, M/s Ora -Tech Systems (Pvt.) Ltd is the single bidder, and hence in the light of Rule 38B (d) of Public Procurement Rules 2004, the Committee recommended that, an independent Committee may be constituted to check the reasonability of the price quoted by the single bidder i.e M/s Ora -Tech Systems (Pvt.) Ltd.

11. b) Price Reasonability Committee Conducted its proceedings and Concluded that "the offered price of M/S Ora-Tech Systems (Pvt) Ltd. for Exa-Data – Oracle Hardware & Software Support Renewal at Rs. 310,746,472/-, (exclusive of GST) is reasonable which may be considered for award and further processing".

Most Advantageous Bidder: M/s Ora -Tech Systems (Pvt.) Ltd

In the light of foregoing position, the Procurement Evaluation Committee recommended the award of contract to M/S Ora-Tech Systems (Pvt) Ltd. being the most advantageous bidder at a contract price of Rs. 310,746,472/- (Rupees: Three hundred Ten million, Seven Hundred Forty-Six Thousand, Four Hundred Seventy Two), exclusive of GST, which shall conform with and comply to all the terms and conditions of the Bidding Document. PEC has also decided that the GST will be charged and paid to the supplier/service provider according to the applicable rate at the time of payment, in compliance with Pakistan's Tax Laws.


