- v. Only 01 no. package in the current bidding of weigh stations shall be awarded to one bidder participated either as sole bidder or as a partner in JV. In case any bidder/JV comes responsive in terms of Bill 1, 2 & 3 in one package then his/their next Financial bid shall not be opened. The order of opening of bid shall be same as given in the IFB.
- vi. It may be noted that during Financial Evaluation, bids received shall be compared with the standard estimate prepared by NHA for Bill 1, 2 & 3 and any bid found unrealistic/unbalanced in terms of substantial responsiveness in comparison to the NHA's estimate for each item given in BOQ shall not be accepted. If two or more lowest bids have been found at par then the lowest bidder who has more technical, score in the technical evaluation shall be considered for acceptance.
- vii. The contract will be awarded to the most advantageous substantially responsive bidder after evaluation in light of clauses 13.1 & 13.2. The bidder will quote fix rates for the Operation, Management & Maintenance of weigh stations based on salaries of staff, maintenance of IT equipment, weigh buildings and overhead & profits as per the bid forms.
