In this regard bidder shall provide bank statements of last one year. Bank statements for periods of 01.05.2022 to 24.11.2022 which does not meet the requirement of one (01) year.
- Not in line with Section-III Clause 'e' of bidding document i.e. bidder must have at least two contracts of same nature along-with its completion successfully as main contractor within last ten years awarded by WAPDA / NTDC / DISCOs. The consolidated value of these contracts should at least be equal to 40% of the value of contract for which the bid is submitted.
