Bidder(s) shall provide National Tax No. and Sales Tax No. The bidder should be on Active Taxpayers List (ATL) of FBR (Income Tax & Sales Tax).4. Bidder(s) must submit an authorization certificate from manufacturer or its authorized distributor/agent as proof of their genuineness.5.
