- M/s. Solution Pick being lowest bidder with the total amount of **Rs. 3,136,795/-**, was contacted to provide the work orders (which are relevant with the similar projects) but they failed to provide the relevant documents, subsequently M/s. Vorson (Pvt.) Ltd. being 2nd lowest was also contacted via telephonic conversation to provide the relevant documents but they also failed to provide the same. So, as per bidder eligibility criteria above, M/s Noor Muhammad & Sons has qualified for the subject tender with the quoted bid amount of **Rs. 3,408,540/-**, which is 16.83% higher than the estimated amount.
- In view of above, tender committee unanimously recommends that the work order may please be award to most advantageous bidder i.e. M/s Noor Muhammad & Sons with the total amount of **Rs. 3,408,540/-** for the tender for **RENOVATION OF WASHROOMS AT 12TH AND 14TH FLOOR (PNSC BUILDING)**.
