**MINUTES OF THE MEETING OF THE DEPARTMENTAL TENDER COMMITTEE HELD

NAME OF WORK: TESTING & CALIBRATION OF 3" DIA WATER METERS.

INTRODUCTION

1. To effectively monitor the supply of potable water to KPT Establishment and other residential areas, installation of Water flow meters was started in the month of August-2018 and 90 Nos. of the said meters were installed. The same are in operational state, but to maintain their effectiveness and to avoid any sort of irregularity in flow of water, a periodical check, testing / calibration of these water flow meters is essential in accordance with requirement of the manufacturer.

In Nov-2019, Testing & Calibration of only half of the installed Water Meters 3" Dia i.e. 45 Nos. out of 90 Nos. was carried out and then in June-2021 remaining half of the meters were calibrated periodically. Subsequently, now all the water meter 3" Dia (90 Nos.) needs to be calibrated in order to avoid any losses in measurement of flow of water as the same is one of the main source of revenue generation. Therefore in this regard AXEN (W/S) visited the locations of the said 90 meters (list of these meters is placed at S.No.1/a) and prepared an estimate amounting to Rs.1,922,130.00, place at S.No.1/c, for the following scope of work.

"Testing & Calibration of Water Meters of 3" Dia by any reputed company at site including taking out and re-fixing (if Required) alongwith Transportations and provision of Calibration Certificates of all the meters".

2. According to the Rule 36 (a) of PPRA tenders for the work were invited through KPT / PPRA & MoMA Website 05-09-2023 and received on 02-10-2023.

RECOMMENDATIONS


- 1 Tenders for the work were invited on 02-10-2023, and the first Lowest Evaluated Bid Rs. 952,522.20 (Rupees: Nine Hundred Fifty Two Thousand Five Hundred Twenty Two & Twenty Paise Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. Atlantic Surveyors (Pvt.) Ltd. which is 50.44% below the corresponding estimated cost of Rs. 1,922,130.00 after evaluation appears to be non responsive, as the bidder failed to fulfill the mandatory requirement as published in the Tender Documents. (reference placed at F/A)
- 2 Further in this regard it is submitted that, as per the note of MF & PIO at S.No.15, Bidder M/s. Atlantic Surveyors (Pvt.) Ltd. was contacted for fulfilling the mandatory requirements but, even then firm could not comply with the instructions as mentioned in the Bidding Documents.
- 3 It is also pertinent to mention here that, the offer of the first lowest Bidder seems to be unworkable as it is about 50% below the corresponding estimated cost. Hence, the offer of second Lowest Responsive Bidder which is Rs.1,761,950.50 (Rupees: One Million Seven Hundred Sixty One Thousand Nine Hundred Fifty & Fifty Paise Only) received from M/s. United Switchgear Company (Pvt.) Ltd. which is 08.33% below than the corresponding estimated cost of Rs. 1,922,130.00, may be considered for the work, as re-inviting of fresh Tenders may lead to waste of precious time and there is very much chance of receiving higher rates / bids as per the price inflation in the current market rates.

Therefore, considering the position as explained in the foregoing para, the Committee is of the opinion that, the offer of the Lowest Responsive / Advantageous Bidder M/s. United Switchgear Company (Pvt.) Ltd. amounting to Rs.1,761,950.50 (Rupees: One Million Seven Hundred Sixty One Thousand Nine Hundred Fifty & Fifty Paise Only) only is 08.33% below than the corresponding estimated cost of Rs. 1,922,130.00, may be considered for the subject work.

Hence, keeping in view the need & urgent requirement of work, it is recommended that the Bid of the Second Lowest Bidder i.e. M/s. United Switchgear Company (Pvt.) Ltd may be considered for the work viz. **TESTING & CALIBRATION OF 3" DIA WATER METERS.**
