Technical and financial evaluation was carried out.</p> <ol style="list-style-type: none"> M/s Zuum Services Islamabad rates were not accepted by the purchase committee as they have mention three ranges of LED price which is illogical as it exceeded the bidding amount. M/s Ascent Industries Pvt limited disqualified due to wrong quotation shared in bidding process. M/s Margalla trader's rates has not accepted being on higher side. The purchase committee technically and financially accepted the rates quoted by M/s AR&FD Traders, Islamabad.
