As M/s Siddique Son is not delivering the material to LESCO due to litigation, hence offer of M/s Mighty is declared as non-responsive on the following grounds: iii. Two of the beneficial owners of M/s Mighty Corporation are also shareholders of M/s Siddique Sons. As M/s SSE is not delivering the material to LESCO against LESCO tenders due to litigation, hence, offer of M/s Mighty Corporation is declared as non-responsive as per clause 11.1 (a) 27 of the bidding document. iv.
