The manufacturer of quoted motorcycles must have at least ten (10) years of experience in local manufacturing of Motorcycles as requisitioned in the bid. <u>Documentary evidence must be provided with bid.</u>2. The bidder must have executed at least six (06) contracts of similar nature and size as requisitioned in the bid during last three (03) years with public/private sector organization(s) out of which at least two (02) contracts of similar nature and size must be executed during the last one (01) year.3. Availability of at least one (01) 3S (Sales, Service and Spare Parts) manufacturer's dedicated facility in respective Teshils/Districts where Motorcycles are to be delivered/provided. <u>A list should be provided with the Bid.</u>4.
