#### **CANCELLATION OF TENDER**

National Institute of Oceanography, Karachi, R&D institution working under the Ministry of Science & Technology, Government of Pakistan. With reference to NIO's Tender Notice published in the Nawai Waqt on 12-10-2022 & PPRA for Extension Works of the Biogeochemical & Physical Oceanography Laboratorys & Spaces, Oceanographic Research Sub Station (ORSS), Gwadar. Its technical bid was opened on 07-11-2022 and two bidders were qualified after technical evaluation. The Financial Bids of the qualified bidder were open on 13-01-2023 at NIO Head office after detail review and comments from consultant, we strongly feel that the quoted prices by the bidders are extreme unbalance and also on exceptionally higher side and few items are overloaded upto 45355 % (25m). Variation in 5 items (OH Tank, Flooring, HVAC Commissioning, Grass and False Ceiling) are more than 30M or 60% of estimated project cost. Tender for Extension Works of the Biogeochemical & Physical Oceanography Laboratorys & Spaces, Oceanographic Research Sub Station (ORSS), Gwadar uploaded on PPRA WEBSITE vide TS492272E dated 10-10-2022, has been cancelled. All bidders are requested to kindly withdraw their bid accordingly.
