While taking reading snap of meters using software MRS, mobile processor become too hot and slow due to which MRS software is not working properly causing delay in batch reading.2. The mobile processing time gradually become slow after continuous use in span of one hour.3. While taking reading snaps of meters the data storage took time more than usual which causing delay and due to file storage mobile got stuck.4. The firmware is not up to the mark as per requirement of field formation i.e. not every application update compatible with mobile software in future.5. The camera quality is compromised and important specification like image resolution, image stabilization and picture quality is not up to the mark.6. Picture/image quality is inferior in low light.7. Mobile consumed battery more than usual using MRS software and other application.8. The battery timings is not efficient as required in field for taking reading snaps of meter.9. Regular updates are not available from its manufacturer.10. Sensors at time start malfunctioning like brightness get increase automatically.11. The mobile display is large and its screen glass is very sensitive. Moreover the bidder has also not provided the following mandatory documents: <ol style="list-style-type: none">i) A list of clients to whom the bidder has done similar business during last 3 years.ii) Stock availability certificateiii) Completely filled performance certificate.
