## MINUTES OF MEETING



The advertisement of the tender for provision of Security Guards in different GPOs and Post offices of Northern Punjab Circle Rawalpindi was uploaded on the Website of PPRA vide reference NO: **TS440759E dated 08-01-2021** besides publishing in the print media for giving wide publicity among the interested parties.
  3. Seventeen security companies got the tender documents.
  4. Only 15 participated in the tender process whereas the company mentioned at Sr. No. 10 & 15 were absent during tender process.
  5. The tender was opened in the presence of representatives of companies mentioned at Sr. No. 1-17 at 1130 hrs.
  6. AS per TORs of tender the technical bids were opened first in the presence of representatives of present companies.
  7. The tender committee scrutinized the technical documents/ bids
