

MINUTES OF THE FINANCIAL-BID OPENING DATED 19-03-2024.

SUBJECT: FINANCIAL BID OPENING MEETING MINUTES FOR THE ACTIVITY TITLED
"DEVELOPMENT OF ECE CLASSROOMS IN EDUCATION INSTITUTIONS OF FDE"

Reference to the advertisement published in the national dailies vide **PID (I)4624/23** dated **02-02-2024**, and the subsequent publishing of the bidding document via PPRA **TS531898E**, a pre-bid meeting was held on the premises of the Project Coordination Unit (PCU) of the Ministry of Federal Education and Professional Training (MoFEPT) dated 09-02-2024 in which all the necessary queries were answered. As mentioned in the advertisement, the extended final date of submission of bids was **21-02-2024**, and the technical bids were opened on the same day at 10:30AM. The total of two vendors participated in LOT-2 and six participated in LOT-1. In the next few days, the proposal of these vendors was thoroughly examined against the criteria set forth in the RFP document. Based on the technical evaluation report, that was published on the PPRA website via reference **EV59029** on **12-03-2024**, only one remained responsive for LOT-2 (M/s Kasib Builders and Developers) while three remained responsive for LOT-1 (M/s Nisar Brothers & Associates, M/s Ittehad Traders, and M/s Danyal Traders).

2. The financial bid opening for the said procurement activity was scheduled for **19-03-2024** at 12:00PM on the premises of the Project Coordination Unit (PCU) of the Ministry of Federal Education and Professional Training (MoFEPT). All the technically qualified vendors were intimidated in advance. The financial bid opening was attended by the following M/oFE&PT members:

- ii Procurement Specialist, PCU, M/oFE&PT (Secretary)
- iii Project Director, FDE, M/oFE&PT (Member)
