At 1st step, the evaluation of tender bids has been undertaken based on the general eligibility of the firms and the quotations/bids offered by the bidder against the technical specifications invited in the tender documents.

Technical Evaluation:

Compliance of all technical specifications mentioned in this bid document was mandatory. Technical evaluation was done on compliant/non-compliant basis. Below specification on partially complaint proposals was declared as Non-compliant. Technical compliance criterion given in bid document was used for evaluation.

Technical evaluation was conducted on 27th day of January 2020 and it was concluded that Three (01) firms (M/s Simpex International, Rawalpindi) was technically non-compliant on the basis of outdated cnic and unavailability of Affidavit of blacklisting.

However, it was found that two bidding firms (M/s Khurshid Enterprises, Islamabad and M/s Nasir Impex, Karachi) were found technically responsive and qualified for the financial evaluation.

Financial Evaluation Criteria:

Technically compliant bidders were considered for financial evaluation. Responsive bidders on basis of total quoted cost (Inclusive of all applicable taxes and excluding any discount), were assigned ranking in ascending order i.e. bidder offering lowest evaluated price was placed at top and be called as "Lowest Evaluated Bidder".

Financial evaluation was conducted on 12th day of February 2020 and details are given in the table below




