1. Additional Information (GRC Decision)

The aggrieved Bidder at S#1 above namely Sultan Mehmood & Company (SMC), Sultan Mehmood and Sons (SMS) and Zhejiang Orient Engineering Company(ZOEC) China (SMC-SMS-ZOEC) JV filed a petition seeking remedy before the Grievance Redressal Committee (GRC) constituted by the competent authority Vide. Notification No. SWP-GRC-1(III)/2022-23/284 dated 20th April, 2023 and NO.SWP-GRC-1(III)/2022-23/1707 dated 1st February, 2024.

The GRC thoroughly investigated the bidding process and declared that the entire bidding process of Bid Evaluation Committee (BEC) is fundamentally incorrect and liable to void ab initio in terms of IB.32 of the Bidding documents which dictates that the employer has right to reject any or all bids before award of the Contract.

Consequently, the GRC declared the bidding process null and void. This decision necessitates the re-bidding of the project contract, with the date for re-bidding to be announced shortly. The aim is to ensure fairness, transparency, and adherence to the procurement guidelines, rectifying the errors identified during the GRC's investigation.
