- 3. Out of the five (05) companies/firms, two companies/firms i.e. M/s Abbaseen Associates and M/s Creative stands technically qualified for further process i.e. sample evaluation, while remaining three (03) companies/firms stands disqualified on the basis to not fulfill the basic criteria as per clause 16 of tender documents.
- 4. Samples of two (02) qualified firms were handed over to Manger Production for their evaluation. Samples of both firms were examined by the Production section being the end user, in response Production section has provided inspection report with remarks that "Samples of both companies are ok, but samples of M/s Abbaseen Associates are comparatively better then samples submitted by M/s Creative technologies.
- In view of above, two (02) companies/firms stands qualified one the basis to fulfill the basic criteria as per clause 16 of tender documents and sample evaluation. Both companies are qualified for further process i.e. opening of financial bids, therefore Purchase Committee recommended to open the financial bids of following two (02) qualified companies/firms for supply of Bleach Paper Boxes as detailed below:
 - i. M/s Abbaseen Associates
 - ii. M/s Creatie Technologies
- 6. The committee evaluated the financial bids of two (02) technically qualified companies. Chairman purchase committee announced the rates of each size of Bleach Paper boxes of both companies. The evaluation results are as under.
