INTRODUCTION:

Amidst, the handing over of East Wharf to KGTL, the entire Port activity has been shifted to West Wharf, which includes frequent visits of dignitaries. Asstt. Electrical Engineer (S-II) vide his e-mail placed at S.No. 1 has requested to attend the subject work.

AXEN (MIY) has surveyed the site and found that only one wooden compartment office is made but remaining two wooden compartment offices are required to be made instantaneously where two officers and their staff are facing hardly to work in open hall alongwith other allied works for tiling & paint works.

In-order to resolve the issues, AXEN (MIY) has prepared an estimate amounting to Rs.967,207.50 (including Taxes and Contingencies) placed at S.No.2 to attend the work through outsources as the same is beyond the limits of In-house arrangements.

Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 23-01-2025.
