INTRODUCTION:

1. The Dy. Chief Mechanical Engineer (Tans. & Equip) being resident of subject flat vide his letter placed at S.No.1 has requested to attend the repair works at CK-06 of KV-38. The accommodation was visited by AXEN / Sub Engineer (KV) and observed that the KPT official accommodation is in much dilapidated condition hence needs repairs work to make the same in livable condition.

Accordingly, AXEN (KV) has prepared an estimate along with plan placed at S.No.2 (A) & 2 (B) respectively, to attend the same through outsource as the same is beyond the scope of in-house arrangements.

2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through KPT, MoMA & PPRA Website and received on 11-01-2024.

Khadija Enterprises which is 0.36% above the corresponding estimated cost of Rs.994,880.00 based on KPT draft amended schedule of rates (2002) 2013 and as per current market rates is considered reasonable.
