
- i. **M/s Security Organizing System Pakistan (Private) Limited:** The specifications of the M/S Security Organizing System Pakistan (Private) Limited is complete in all respects with the specifications mentioned in the tender and has obtained 100/100, however, the company has quoted high rates i.e., Rs.44,396/- per person.
- ii. **M/S Himalaya Security Services (Private) Limited:** The offered bid and specifications of the M/S Himalaya Security Services (Private) Limited is complete in all respects with the specifications mentioned in the tender and has obtained 81/100, and the company quoted lowest rates i.e., Rs.40,600/- per person.






