

Bidder(s) must have at-least three (03) years of experience of similar nature as requisitioned in the bid. ii. The bidder(s) must provide copies of supply orders to establish the required experience. iii. Bidder(s) must provide Complete List of Clientele including details of atleast 2 current clients alongwith their contact information. iv. Bidder(s) shall provide National Tax No. and Sales Tax No. The bidder should be on Active Taxpayers List (ATL) of FBR. v. Bidder(s) must submit Manufacturer or Authorized Dealer's Authorization on the format provided in Section IV of the bidding documents vi. Bidder(s) must provide the leaflets/ brochures/ catalogs of quoted product with the bid vii. The bid and price schedule should be submitted on the prescribed format on company's letterhead. Both must be properly signed and stamped by the authorized person. viii. Earnest Money as mentioned at following ITB clause 13.1 must be furnished from scheduled Bank of Pakistan; ix. No offer on itemized basis will be accepted. (iii) The Bidder has to quote only one rate for the equipment as per Bid's specification. No alternate model/bid or separate accessories shall be accepted. (iv) Compliance to the technical specification as proposed in Section III of Bidding Document.
