For Lot-6, if the bidder has not performed any deployment within the country, he can provide list of 2 current clients alongwith their contact information from outside the country.</li> <li>6. **Note:**

The designated Procurement Evaluation Committee (PEC) observed that although the bids of M/s Mega Plus for Lot-2 i.e Rack Mountable Servers, M/s Staybiz International for Lot-3 i.e RAM Up gradation from 2 GB to 8 GB, M/s CNS Engineering for Lot-6 i.e. Network Access Control and M/s Nasco Traders for Lot-8 i.e Multimedia Projectors were responsive, however, they were the single responsive bidders for these Lots. In order to establish the reasonability of quoted prices of these lots the Price Reasonability Committee constituted for the said purpose conducted market survey on the basis of which the price quoted by M/s Mega Plus for Lot-2 i.e Rack Mountable Servers and M/s CNS Engineering for Lot-6 i.e. Network Access Control were found reasonable. However, for Lot-3 i.e RAM Up gradation from 2 GB to 8 GB the Committee observed the price quoted by the lowest evaluated bidder on higher side. Further, for Lot-8 i.e Multimedia Projectors (Boxlight ANWU-405) the Committee did not succeed to get any comparable rate from the market, as the same brand is not available in the Market. Therefore, on the recommendation of PEC, Management of BISP has decided to re-invite the bids for these two Lots.
