

MINUTES OF THE FINANCIAL-BID OPENING DATED 19-03-2024.

SUBJECT: FINANCIAL BID OPENING MEETING MINUTES FOR THE ACTIVITY TITLED "UPGRADTION OF 50 COMPUTER LAB IN EXISTING FDE SECONDARY & HIGHER SECONDARY IN RURAL ICT BOYS SCHOOLS"

Reference to the advertisement published in the national dailies vide **PID (I)4723/23** dated **07-02-2024**, and the subsequent publishing of the bidding document via PPRA **TS532003E**, a pre-bid meeting was held on the premises of the Project Coordination Unit (PCU) of the Ministry of Federal Education and Professional Training (MoFEPT) dated 15-02-2024 in which all the necessary queries were answered. As mentioned in the advertisement, the final date of submission of bids was **22-02-2024**, and the technical bids were opened on the same day at 10:30AM. The total of four vendors participated in which M/s Analytical Solutions was deemed non-responsive while the proposal submitted by M/s PTCL Solutions was partially complied with. However, M/s PTCL Solutions become responsive when its representatives satisfied the committee query regarding the audit report. In the next few days, the proposal of the three vendors were thoroughly examined against the criteria set forth in the RFP document. Based on the technical evaluation report, that was published on the PPRA website via reference **EV59030** on **12-03-2024**, only two remained responsive: M/s A.N.Q Associates and M/s Bilal & Sons. The proposal of M/s PTCL Solution become non-responsive due to the fact that their quoted specifications differ significantly from the RFP design specifications. Consequently, M/s PTCL Solutions submitted the grievance against the technical evaluation on **13-03-2024** which was referred to the grievance redressal committee. Nevertheless, the grievance committee in its decision (**F.No 1-1/2021/DS (A)**) dated **18-03-2024** decided to uphold the initial decision of the evaluation committee.

2. The financial bid opening for the said procurement activity was scheduled for **19-03-2024** at 3:00PM on the premises of the Project Coordination Unit (PCU) of the Ministry of Federal Education and Professional Training (MoFEPT). All the technically qualified vendors were intimidated in advance. The financial bid opening was attended by the following M/oFE&PT members:

3. The following bidders participated in the financial bid opening:

- ii M/s Bilal and Sons

4. Before formal commencing of the financial bid opening with vendors, the chairman requested the Procurement Specialist and the MIS Specialist to provide an overview of the proceedings thus far. The aim was to ensure all committee members were fully informed about the progress and to recapitalize all relevant details of the procurement activity. During the briefing, the MIS-Specialist raised a question about verifying the MAL certification from the technically qualified vendors. The procurement specialist responded that third-party verification would occur after the final selection and contract award. However, the chairman requested a recheck of the documentation for the two qualified vendors. Consequently, the MIS-Specialist cross-verified the documentation for both

vendors, confirming its completeness. Following this, the chairman approved proceeding with the financial bid opening, and the vendors were summoned to the meeting room.

5. The procurement specialist began by unveiling the financial proposal of M/s A.N.Q Associates, followed by M/s Bilal and Sons, and disclosed their respective costs. Some vendors had quoted for both solarization options (10 kW and 15 kW) as discussed in the pre-bid meeting. However, the committee unanimously agreed to consider the 15-kW option for final evaluation. The summarized breakdown of costs is detailed in the table below:
