However, the price of Flu Vaccine quoted by M/s Lab Diagnostic System is over & above the maximum MRP approved by DRAP for Flu Vaccine (Teratect) and its procurement is against the PPRA's Rule-2004 with this high price, so the bid is rejected on the basis of high quoted price.
