- 8. The Bidder shall prepare a complete list of items ("Deviation List") set out in Schedule 6 which is deviated from the Company requirements listed in Schedule 2.
- Items not listed in the Deviation List shall be deemed as being fully complying with the Company Functional and Service Specifications requirement.
 - If in the event any inconsistency exists between the Service Specifications and Bidders description which is not listed on the Deviation List, the Service Specification shall prevail.
 - ii. If the Bidder fully complies with the Service Specification and has no deviation item, write "NONE" on the Deviation List Form. A Tender without the Deviation List Form may be disqualified.
- 10.
