At 1<sup>st</sup> step, the evaluation of tender bids has been undertaken based on the general eligibility of the firms and the quotations/bids offered by the bidder against the technical specifications invited in the tender documents.

**Technical Evaluation:**

Compliance of all technical specifications mentioned in this bid document was mandatory. Technical evaluation was done on compliant/non-compliant basis. Below specification on partially compliant proposals was declared as Non-compliant. Technical compliance criterion given in bid document was used for evaluation.

The initial advertisement for the tender F.2-11(2)/2019-20/FPMU containing De-stoning machines was floated on 25-11-2019 with opening date of 12-12-2019. Only one of the three bid receiving firm submitted bid documents for evaluation. However being the sole authorized company and owing to the fact that such machine was to be installed in Pakistan for the first time this single bid was considered for financial evaluation. After the Financial evaluation on 26<sup>th</sup> day of December, 2019, the procurement committee decided that given the prices quoted by the firm in the bid were too high, the tender is to be re-advertised.






